INSTRUCTIONS FOR WITNESS FORMS FOR THE ARCHDIOCESE OF KANSAS CITY IN KANSAS

Instructions for completing the Freedom to Marry Witness form for the Archdiocese of Kansas City in Kansas for marriages outside the Archdiocese:

The Groom **OR** the Bride's name goes on the line marked, "Groom/Bride," depending on who the witness is for.

The witness's name goes in the line marked, "Witness to be named by party."

The witness's address goes on the lines marked, "Street, City."

The priest or deacon preparing you for the marriage goes on the line, "Person Arranging Marriage."

Please fill out the rest of the form and answer the questions on the "Testimony of Witness" section.

For the section, "If Proof of Baptism is needed": if you know the baptismal information, you may enter it. Otherwise, if you have submitted the baptismal certificates to the priest or deacon arranging the marriage, he can submit it with the prenuptial paperwork and you don't have to fill this section out.

Do not sign the form unless you have read the next step:

Either the signature of your pastor with the parish seal **OR** a notary is needed at the bottom of the form.

Therefore,

(1) Sign the form where it says "Witness," and ask your parish priest to sign at the bottom on the signature line and affix the parish seal by his signature,

OR

(2) Have the form notarized. If you are going to notarize it, you **MUST** sign it in the presence of the notary on the line that says "Witness." Otherwise, the notary must refuse to notarize the document by law. You will need to print out a new one and start over.

Mail the form to the Archdiocese of Kansas City in Kansas Tribunal Office (address on the form) or to the priest preparing you for your marriage. Please do so in a timely manner so that your couple's church paperwork can be processed without delay.

Please Note:

The Tribunal Office of the Archdiocese of Kansas City in Kansas requires that two witness forms be filled out for the bride and two for the groom. The witnesses must be at least 18 years of age and can be parents, other relative or a close friend that knows the couple. The engaged couple can even use the same witnesses, but separate forms must be filled out.
