
TRAGIC CONSEQUENCES

Many Kansans were intentionally misled by the abortion industry and its allies into thinking by rejecting the Value Them Both Amendment, they were simply preserving access to early, first-trimester abortions only, helping women with ectopic pregnancies get life-saving medical treatment that VTB would somehow prevent as the abortion industry falsy alleged, or ensuring that limits and regulations on the abortion industry would remain. In reality, Kansas has become an abortion destination state, without any meaningful restrictions or protections for pre-born children or women's safety. The legal door is open to having all abortion regulations challenged.

ABORTIONS IN KANSAS


- Abortions in Kansas have skyrocketed from roughly 6,900 to an estimated 20,000 since the vote (We Count Report, Oct, 2023), and many protective laws have been lost or sued.
- Approximately 60% of all abortions in Kansas appear to be a result of the "abortion pill" a two-step "DIY" protocol. The abortion industry claims that chemical abortion is safe, yet peer-reviewed science and data say otherwise. The rate of abortion pill related emergency room visits has increased more than 500% over the past decade, putting mothers at significant risk for greater complications in addition to inflicting trauma from seeing their aborted baby (lozierinstitute.org)
- According to the Guttmacher Institute, the abortion industry research arm, there are 65-70 abortions in Kansas taking place each day.
- Since 2022, there are two new abortion facilities in Kansas, with another opening in Pittsburg, KS soon.

PROTECTIONS LOST

The KS State Supreme Court declared that basic abortion clinic licensing laws and inspections are unconstitutional and will not be enforced.

Painful, live-dismemberment abortions are still legal in Kansas

The abortion industry filed a lawsuit against the KS Woman's Right to Know Act passed in 1997. All of its protections are not being enforced including informed consent, abortion risk information, a waiting period, a right to see an ultrasound & information on abortion pill reversal.
