Texas about to Have a Life Monument Near the Capitol Building

Governor Greg Abbott recently signed into law a resolution to place a six-foot bronze statue of a mother with a preborn child on a two-foot base near the Texas Capitol building in Austin. This showed a strong commitment to defending life from the moment of conception. Senator Tan Parker, a classmate from the University of Dallas and close friend of mine, sponsored the measure, SCR19, in

the Texas Senate, and Representative Caroline Harris Davila sponsored it in the Texas House.


Fr. Tad comments on how the U.S. has long been involved in pro-abortion and anti-family imperialism, especially in the manner by which it distributes various kinds of aid to poor countries. He argues the US taxpayer should not be, directly or indirectly, funding the acquisition and shipping of 26 million condoms, 2 million doses of injectable birth control, millions of packages of oral birth control, and hundreds of thousands of implantable contraceptive devices to foreign countries. He stresses that it is not appropriate for

the US, and US aid agencies, to be serving as middle men, underwriters, or imperialist brokers in these transactions.

“Theology and philosophy are not considered a science, scientific. But theology and philosophy can yield real metaphysical truth, but you have to recognize it. Catholic Church Urges UK Parliament to Vote against Assisted Suicide Bill

Labour MP Kim Leadbeater’s Terminally Ill Adults (End of Life) Bill is fast approaching its decisive vote in the House of Commons which will likely take place on either the 13th or 20th of June.
