They were originally created to help couples avoid pregnancy, and the general term used at first, natural family planning methods (NFP), reinforced this perspective.

### **The Arguments by the United States and Their Amici Are Based on a Tragic Misunderstanding of Gender Incongruence and Dysphoria in Children**

The world has witnessed an exploding number of gender-dysphoric children. And, while a significant segment of the international medical community has put a pause on hormonal and surgical interventions for children following the comprehensive review of the medical evidence by Dr. Hilary Cass for the National Health Services England ("Cass Review"), many U.S. advocates continue to silence debate around their preferred aggressive experimental medical interventions beginning at the onset of puberty or even earlier. Such interventions include puberty blockers and cross-sex/wrong-sex hormonal intervention followed by radically invasive surgeries for minors experiencing what studies show is most often a temporary issue in young people. And, as the growing number of "detransitioners" attests, their permanent scars and resulting infertility from these unproven interventions cannot be undone, no matter how great their regret. In the statute at issue in this case, Tennessee lawfully acted to protect its children from these enormous risks and harms.

### **The Terminally Ill Adults (End of Life) Bill 2024-25**

Any law that allows the government, through legislation, to decide that some individuals' lives are not eligible for its protections is discriminatory. When government secures such rights for some but not others, when it relaxes laws against aiding the suicide of terminal patients but not the able-bodied, it is saying: this class deserves less care and protection; its members deserve fewer safeguards of their human rights. In other words, they deserve less respect because in some way they are less human. Such discriminatory processes, as fostered by The Terminally Ill Adults (End of Life) proposal, must be opposed.

## **Trump Admin Rescinds Harmful Biden-era Abortion Mandate**

The Trump administration rescinded a Biden-era mandate that attempted to force emergency room doctors to perform abortions under the Emergency Medical Treatment and Labor Act. Because the administration's action now protects mothers, unborn children, and doctors' conscience rights, Alliance Defending Freedom attorneys filed a voluntary dismissal of the lawsuit they had filed against the Biden administration earlier this year to challenge the mandate.

## **New U.S. Embryo Screening Firm Raises Specter of "Designer Babies"**

Father Tad discusses the concerns surrounding a new U.S.-based biotech company, Nucleus Embryo, which offers genetic screening and profiling for those seeking to do IVF. These quality control techniques sift through and discard those embryonic children who do not make the cut and are less than perfect. Fr. Tad notes how: "Society's demand for physical perfection places untold pressure on couples today to 'conform to the norm' by aborting or otherwise eliminating any less-than-perfect children," thereby encouraging

people to treat their own offspring as discardable raw material rather than as the unrepeatable gifts and blessings they actually are.







## **Supreme Court Rules in Favor of Nuns Fighting New York Abortion Mandate**

The Supreme Court has ordered New York courts to reconsider *Diocese of Albany v. Harris*, a case challenging New York's abortion mandate, in light of Becket's unanimous victory in *Catholic Charities Bureau v. Wisconsin Labor & Industry Review Commission*. In 2017, a group of Catholic and Anglican nuns, Catholic dioceses, Christian churches, and faith-based social ministries challenged New York's mandate forcing them to pay for employees' abortions. After New York courts declined to protect the faith groups, Becket and Jones Day asked the Supreme Court to step in.

## **Supreme Court Upholds State Bans on Transgender Care for Minors**

The U.S. Supreme Court on Wednesday upheld laws in roughly half the states that ban gender affirming medical care for transgender minors. The vote was 6-3, along ideological lines.

## **With Abortion and Euthanasia Votes, the U.K. Rejects the Basis of Every Human Freedom**

Two votes in the British Parliament this week sent a stark message to the rest of the world: The U.K. government no longer values the lives of its people, and by extension, their liberties. The House of Commons, the only elected body in Parliament, voted 314-291 on Friday to legalize state-assisted suicide for terminally ill adults who have been told they have less than six months to live.
